CONGRATULATIONS on your purchase of a new Naturepedic product. At Naturepedic, our goal is to provide quality materials and workmanship in the construction of our products. As such, each Naturepedic product is crafted with the finest materials. If, however, you discover a material defect in your Naturepedic product, review our warranty below and contact us at 1-800-91-PEDIC for instructions on how to make a warranty claim.

### Arienzo Furniture Limited Warranty

**Who and what does this Warranty cover?** This warranty is not transferable and only covers you if you are the original purchaser and owner of one or more of the following Naturepedic products ("Furniture") and purchased it directly from Naturepedic or from an authorized dealer: Arienzo Bed Frame, Arienzo Dresser, Arienzo Mirror, Arienzo Chest, and Arienzo Nightstand. Because we strongly believe in the quality, design, and craftsmanship of our products, our products are warranted against defects in workmanship and material for your Naturepedic Product you have purchased when used normally for its intended residential purpose and in accordance with our use and care instructions.

**What will Naturepedic do?** If, after inspection, the Furniture is found to be covered under this warranty, we will repair or replace the Furniture, subject to the limitations and exclusions herein. Naturepedic reserves the right to substitute material or product of equal or higher quality. Replacement does not extend to the original period of limited warranty, nor does it constitute the beginning of a new limited warranty period.

**How long does the coverage last?** For purchases of Naturepedic Furniture, this warranty lasts for ten (10) years from the date of purchase. The first five (5) years are a full component repair or replacement warranty. The last five (5) years will be prorated based on a 50/10 percentage basis. Starting at the 6th year, you will receive a repair or replacement credit equal to 60% of the original component price. The credit will decrease by 10% each year for the following four (4) years. If the Furniture is used in a commercial facility (e.g. hotel) then this Warranty is limited to five (5) years, non-prorated.

**What is not covered by this Warranty?** Every Naturepedic product is individually constructed. As such, some degree of individualization of the finished product is an inherent part of that process. Imperfections that do not prevent reasonable continued use of the Furniture are not considered to be defects.

This warranty excludes: (a) minor imperfections and slight cosmetic flaws; (b) normal wear and tear as a result of intended use; (c) physical abuse or damage to the product, including but not limited to burns, nicks, cuts, tears, liquid damage or stains; (d) personal comfort or style preference; (e) damage resulting from cleaning methods including but not limited to chemical cleansers, abrasives, furniture polish or wax; (f) naturally occurring aromas; (g) damage incurred by the customer moving, transporting or relocating the product; (h) damage resulting from exposure to heat and humidity fluctuations caused by direct sunlight or extreme temperature; and (i) variations in wood grain or texture due to the natural character of wood.

In addition, this warranty does not cover conditions resulting from abusive handling, misuse, or neglect, or a cause other than defective workmanship or materials, and the following, if found upon inspection, will void your warranty: (a) damage due to physical or electrical misuse or abuse; (b) any unsanitary condition; (c) failure to comply with user instructions for use and maintenance, including weight limits and operation; (d) modifications, repairs or replacement of Furniture parts by an unauthorized person; (e) use of any parts, components or accessories that are not supplied by Naturepedic for the specific product; (f) improper storage of the Furniture; (g) dampness; and (h) improper or inadequate return packaging. This warranty does not cover shipping charges associated with returning the damaged Furniture or with shipping any replacement product.

**ADDITIONAL LIMITATIONS: THIS WARRANTY DOES NOT COVER DAMAGES IN EXCESS OF THE PURCHASE PRICE THAT YOU PAID FOR YOUR PRODUCT. ADDITIONALLY, TO THE EXTENT PERMITTED UNDER STATE LAW, INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES ARE NOT COVERED BY THIS WARRANTY. FOR COMMERCIAL AND ALL OTHER NON-CONSUMER USE, THERE ARE NO WARRANTIES BEYOND THIS WARRANTY EXPRESSLY STATED ABOVE, INCLUDING WITHOUT LIMITATION IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE, WHICH WARRANTIES ARE HEREBY SPECIFICALLY EXCLUDED. IF YOU ARE A CONSUMER WHO PURCHASED YOUR PRODUCT FOR PERSONAL, FAMILY, OR HOUSEHOLD PURPOSES, THE AFORESAID IMPLIED OR STATUTORY WARRANTIES ARE LIMITED TO THE DURATION OF THIS EXPRESS WARRANTY OR THE MINIMUM PERIOD PERMITTED BY LAW.**

**Your rights under state law:** Some states do not allow the exclusion or limitation of incidental or consequential damages in connection with the sale of consumer products, so the above limitation or exclusion of incidental or consequential damages may not apply to you. This warranty gives you specific legal rights, and you may also have other rights that vary from state to state. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

**Other terms and conditions:** Naturepedic makes no medical or health claims regarding its products. Allergies, discomfort, or other conditions are not covered under this warranty. Any questions or concerns regarding medical or health conditions should be addressed by a licensed physician.

**BINDING ARBITRATION NOTICE: YOU AGREE THAT DISPUTES BETWEEN YOU AND NATUREPEDIC WILL BE RESOLVED BY MANDATORY BINDING ARBITRATION AND YOU WAIVE ANY RIGHT TO PARTICIPATE IN A CLASS-ACTION LAWSUIT OR CLASS-WIDE ARBITRATION.**

**PLEASE READ THE FOLLOWING PARAGRAPHS CAREFULLY BECAUSE THEY REQUIRE YOU TO ARBITRATE DISPUTES WITH NATUREPEDIC AND LIMIT THE MANNER IN WHICH YOU CAN SEEK RELIEF FROM US.**

Any dispute, controversy, or claim arising out of or related in any way to this Agreement or any services performed hereunder which cannot be amicably resolved by the parties shall be solely and finally settled by arbitration administered by the arbitration agency selected by Naturepedic (for example, the National Arbitration Mediation organization), in accordance with its commercial arbitration rules. Judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. The arbitration shall take place before a panel of either one or three arbitrators, the number of which selected by Naturepedic, sitting in Geauga County, Ohio. The language of the arbitration shall be English. The arbitrators will be bound to adjudicate all disputes in accordance with the laws of the State of Ohio. The decision of the arbitrators shall be in writing with written findings of fact and shall be final and binding on the parties. Each party shall bear its own costs, including attorney's fees, relating to the arbitration proceedings irrespective of its outcome. If there is a joint cost because of the arbitration, such as the arbitration fee, then the parties will equally split that cost. This section provides the sole recourse for the settlement of any disputes arising out of, in connection with, or related to this Agreement.
