## **Tracking Labels:**

## **Product Registration:**

Per the Consumer Product Safety Commission (CPSC) regulations regarding product registration (CPSIA Section 104 “Standards and Consumer Registration of Durable Nursery Products” which requires product registration for all durable infant or toddler products with a useful life of three or more years), the types of products produced by Lullaby Earth do not require product registration.
